IN ORDER TO PRODUCE AND FACILITATE OUR PROGRAM OF SUMMER EVENTS (WHICH ALTHOUGH MUCH REDUCED DUE TO SAFETY RESTRICTIONS) INCLUDED:-

Twice weekly in house **drop in summer schools for kids** 7-16 yrs old (usually minimum of 20 kids per session).

United Downs Raceway Grafitti Art Project in collaboration with (Cornwall Neighbourhoods for Change (CN4C), and the Why Don't You Youth Club – for 30 local young participants their siblings and parents / guardians.

United Downs 'Wacky Raceway' – 1 day of circus workshops, soap box derby's and circus shows from Airfish Circus and our Home Ed Circus School (aka The CDC All Stars) for 300 local participants.

United Downs 'Funderdome' – 2 days of circus workshops, messy family orientated games, and circus shows – for 350-400 participants from the local community.



CDC has been able to collaborate and cross pollinate with Airfish Circus and it's members, with HotchPotch Performance and it's members, Pokya Entertainment and Yskynna Vertical Dance members similarly, to facilitate events; work and performance experience opportunities for young people and enthusiastic adult amateurs; for on and off site workshops and fundraising events, to help CDC in engaging and supporting the local community, utilising the creative arts to do so. These local groups have been open to supporting CDC in facilitating student galas, CDC produced events and fundraisers for approximately 3 years to date.

During the pandemic many of these folk, and many of our users and users family members, helped CDC to identify and support community members in crisis in collaboration with Cornwall Community Foundation and Cornwall Neighbourhoods for Change, in meeting their immediate needs via hardship grants (£20K in total), re Heating, Clothing, Provisions, and via our foodbank provision and deliveries, in collaboration with the C.I.O's 'Sparkle Foundation' and 'Fare Share'.

Since re-emerging in 2021 to create performance works, CDC has **commissioned 1**

local artist (Cosmic Images) & 1 regional maker (Tim Timms) to assist with 1 youth art project at United Down Raceway, and to create art pedal go karts, and various soap box vehicles from scrap materials for CDC's event, Wacky Raceway'. These will be reused in collaboration for another community event planned at the raceway in October 2021, that receives support from the Arts Council England 'Bangers and Mash Up'.

CEMENTING TIES WITH THE ACORN THEATRE PENZANCE

Since 2019 CDC has also had an excellent relationship with the Acorn Theatre Penzance, providing Family Friendly Circus Skills sessions there, so children and their parents can learn together. This provision has now been restarted post Covid on behalf of CDC by Ruth Hawkley who conducts these sessions once weekly, roughly in synch with term time over in Penzance, during after school hours on a Monday.

These sessions prove very popular and there is always a waiting list for them. Their popularity is indicative of the lack of available effective, engaging resources and activities for the community in the area, particularly young people and women.

In 2021 CDC assisted the Acorn Theatre to replace it's existing aerial truss, for a new one, required to meet Height Safety criteria, with due regard for the theatre's listed status and beautiful ceiling design. In order to support the theatre's continued ongoing support of the Circus Arts in Cornwall, and to ensure that a theatrical venue on the South Coast can always accommodate local and touring circus artists and companies. As well as continue to try to serve the local need and demand for family friendly and adult circus skills in the area.

CREATING ADDITIONAL JOB OPPORTUNITIES THAT POSITIVELY PROVISION THE LOCAL COMMUNITY

Through our works we not only provide access to the circus arts, we foster creative opportunity, create paid work for artists and coaches, learning and collaborating to high standards. We bring extraordinary work created and performed by ordinary people and young upcoming talent alike. Through that work we enrich our local events, and our local community, and successfully engage with the community, creating access, meaningful opportunities and more Circus Arts enthusiasts, and strong, healthy, happy people as we go.

To this end we currently have Circus-Naomi, Lisa Truscott, Sequoia Movement, and members of Airfish Circus, Pokya Entertainment, Yskynna Vertical Dance, and Hotchpotch Performance, in house at the Circus Works Devoran coaching adult evening, home ed and after school kids sessions, beginner's to advanced, for age 7-107 years!

We have a full program scheduled in house all week round to support the local community in getting and keeping fit. Also to support the local professional community, and upcoming future professionals, by providing a range of ground based and aerial circus skills training classes, plus supporting strength, cardio, fexibility, hand balancing, overcoming gravity, acro and rings classes.

EXPANDING OUR SERVICES AND COLLABORATING WITH NEW GROUPS

Since re-emerging from the Pandemic restrictions early summer 2021 we have begun to collaborate with community organisations such as Dracaena Centre Falmouth, Berryfield and Kingsman Youth Clubs in Bodmin (working in conjunction with Devon and Cornwall Police and the U+ project for vulnerable / at risk youngsters). Also with the Over 50's in the Newlyn area, via collaborative pilots with 'The Point'

VOLUNTEERS AND ACCREDITATION.

CDC currently provides work experience options and volunteer hours for young people under the 'Children's University' volunteer passport program, and can issue passports so youngsters can have their hours spent with us accredited. We currently have 5 young volunteers assisting with the in house kids classes. Amy Patrick, Lila Sefi, Oliver Lambourne, Maddie Miller and Jaia Peppiatt.

CDC also supports youngsters through their Arts Awards, their Duke of Edinburgh Awards and also has it's own accredited awards scheme, created by Charlie Ellis in 2012. We also take young people from schools who wish to do work experience with us, and are happy to report our first young volunteer post Covid (Amy Patrick) came to us 5 July 2021.

SUPPORTING LOCAL PROFESSIONALS

CDC also provides local and touring circus and movement pro's and semi pro's training, rehearsal, research and development resources We also provide low cost venue hire to those that wish to generate their own income via freelance coaching and specialist instruction. Thus supporting them in making a decent supplemental income to their seasonal performance work. By doing so CDC ensures that in house students receive quality tuition from real, experienced and current professionals, and benefit from the wisdom of their experience, their knowledge and their guidance in relation to pursuing a career in the physical performing arts.

Work has also been undertaken to R & D 'Unguided'- directed by Adam Cawley, but has yet to be scheduled for a debut performance.

In doing all of this CDC has not only elevated the standards of learning and performance skill sets and increased the range of opportunities, but also raised the level of local resources to do so in relation to all kinds of movement, physical literacy

the physical performing arts, health and well being. It has provided meaningful occupation and healthy positive outlets for young and old within the local community too.

PROVIDING ONGOING TRAINING AND LEARNING SUPPORT TO YOUNG PEOPLE

We are delighted to be able to offer our first 'bursaries' moving forward this year, via the 'Charlie Ellis Fund', in honour of the main driving force behind CDC's creation and ethos. With support grants planned to be allocated for the following:-

Mr Oliver Lambourne – on completion of a successful audition to Montreal Circus School

Miss Lila Sefi – having successfully auditioned for Exeter CAT, to study Contemporary Dance

We have two further youngsters with elite talents in need of support too. Elizabeth Smith age 12 years and Maddie Miller age 14 years.

We are also working at present to create a pilot project for local teens and young people not in employment, education or training. To be called the 'Give Voice' Project, to be piloted upon receipt of suitable funding for a 7 week period. To provide local youngsters with the opportunity to create a performance piece, and a platform on which to perform it. This pilot scheme is to inform the feasibility of creating a longer 6 month perfromance professional development training opportunity, under the auspices of the new government 'Kickstart' scheme to offer as a provision to local young people.

We are currently also working to support our students from the local community, to prepare for their upcoming gala performances at the Acorn Theatre in November.

On top of this we have a packed planned schedule of events for 2022, all designed to improve access to creative, artistic, healthy arts and activities, to foster strong familial bonds and community ties, and to utilise the arts as relevant and useful media and mediums in the building of a more mindful, sustainable and positive future for the region.

ORGANISATIONAL STRUCTURE

The charity has a Board of 6 Voluntary Trustees:-

MEMBERSHIP

CDC has a membership made up of supporters within the local community, plus the pro's, semi pro's, associated freelancers and collective members, and the circus students that use us the most via our Open Training facility. This is because we feel it is important that those who use and support us most have input into our future development.

OUR WORKING PRACTICE

On the one hand we work to the well researched and evidenced models of Dr Reg Bolton Phd*, to bring the equally well researched range of positive benefits:-

- coping with failure
- analysing & mitigating risk taking
- learning team work
- positive personal & social development
- improved health & well being
- greater physical literacy, confidence & self esteem

With circus skill based activities as the delivery vehicle, in creative, artistic, youth, social and community contexts to the community.

On the other we work to provide performative and production opportunities to local, touring, upcoming artists and enthusiastic amateurs. We strive to provide training resources, and access to instructors in the Circus Arts, and a wide range of other movement disciplines. In order to improve and further evolve and develop the Circus Arts, performative skill sets and pedagogy. Thus increasing access to the physical performing arts regionally, raising the standards, improving knowledge and skill sets, building community ties, promoting fun healthy activities and physical literacy and mobility, supporting positive mental health and rewarding forms of expression.

Our main priorities are making the benefits of the circus arts accessible to as many as possible, and ensuring that local talent's access to a professional career is based on passion and ability, rather than financial means.

WHEN AND WHY WE CREATED THE 'CIRCUS WORKS DEVORAN'

CDC created the Circus Works in February 2019 without any external funding. We failed in our National Lottery Funding application to help create the Circus Works, but were successful in generating enough money to get going via some self produced

events, community support, a little help from the corporate sector, and appearances at several local events too.

We created the Circus Works to provide a 'hub' for both the local community and the smaller circus arts community based in the region. CDC was aware that there was nowhere in the region suitably equipped



and qualified to make provisions of a standard required by professional artists, young beginner's, and the wider community alike.

We designed the Circus Works to be adaptable & flexible, able to listen and quickly respond to the requirements of its users.

For example, since September 2021 we are now able to offer sessions on site for youngsters age 2 yrs and up. We are also exploring new avenues off site with Newquay Scouts and the over 50's population in the Newlyn area.

Since June 2019 we have supported 10 young people into higher education to degree level at both Circomedia Bristol, & National Circus Centre. This year sees one of our students already training at weekends in Exeter, on top of her college course in Cornwall, to achieve her Contemporary Dance goals, one travelling to London regularly to train at National Circus Centre, (both via the CAT scheme). With another young man due to audition in Canada for continuing physical perfoming arts training in Montreal.

COVID-19'S IMPACT RE OUR FINANCIAL VIABILITY, RESILIENCE AND SUSTAINABILITY

Had we not

- Received Business Rates Relief* (£10K), and a portion of the Local Business Restriction Grant *(£8K)
- Received a small amount of (unringfenced) corporate funding.
- Generated a small amount of funding via several of our own fundraising events.
- Been permitted to make provisions for circus pros to train, and children of essential workers whilst still receiving *, during lockdowns 2 & 3.
- Been prudent in our financial administration and spending.

The effects of the pandemic and it's restrictions on our continuing health and longevity would have been terminal.

PRE LOCKDOWN

Pre lockdown restrictions CDC generated enough revenue monthly to cover it's fixed overheads in terms of rent and bills. CDC did this via in (and out of) house classes; workshops; productions and performances (for and involving children and adults); pro training and student training memberships; also via freelancer's hiring space and time (for group classes / private sessions).

Due to the diversity and variability of our provisions pre lockdown, CDC would also have unfixed variable costs per month in relation to paying for specialist services



and equipment anywhere from between £500 to £3000 on top of those fixed overheads.

Pre lock down we successfully navigated a path that generated the required revenue to cover our costs sustainably, without having to rely on funding, if we were prudent and cut our cloth according to our means. These factors along with our broad spectrum Articles enabled us to be able to diversify or re-adapt any provisions falling short of being sustainable. Some provisions of benefit we ran at a loss because of the need, in which cases we would reallocate revenue from more successful projects to subsidise them. Most of our provisions being run to cover costs/ break even, not to generate profit. It also meant pre Covid that 100% of any un-ringfenced funding we received could go directly to project work.

DURING LOCKDOWN

The parameters of the legislation put in place during the first lock down shut us down completely, and eliminated 100% of our out of house performance and project work also. We were unable to continue the majority of our educational, training and performance provisions, or support the local freelancers utilising our resources. We were unable to generate any of the revenue needed to cover our fixed overheads, yet we still had to pay full fixed costs in terms of rent, service charges, insurances and utilities to our Landlord throughout.

During lock down 2 & 3 we were allowed to remain open

- to provide professional training facilities to locally based / locally stranded Circus Pro's
- to provide much needed 'Out of School' sessions to Children of essential workers

(Both of which generated very little revenue but proved to be of huge value to the health & mental well being of the community we serve.)

- to remain open to facilitate a foodbank (free produce, run by volunteers),
- to administrate the allocation of Cornish Community Foundation funds via Hardship Grants, Surviving Winter & Crisis Funds, to local folk feeling the impacts of C-19.

We continued to pay full rent, utilities etc to our private landlord, requests for his aid came to nothing. Government support via the Business Rates Relief Grant just about covered around 60% of our fixed costs in relation rental, service charge and utilities bills. Not our insurances, safety inspection fees, or additional costs such as project and instruction, accounting and administration expenditure.

POST LOCKDOWN

We aren't confident of:-

- 'bouncing back' without continuing to have a secure and stable base of operations.
- Continuing to offer the needed provisions we do for the long term. This is what is needed to truly establish and foster firm positive ties within any locality. Despite strong community, professional and multi agency support, collaboration and appreciation of our working practice during the lockdowns.

 Being able to recruit future trainees and volunteers, or required quality, specialist personnel for facilitating those provisions, without offering some measure of confidence that they can be retained, that investing their time and energy is worthwhile.

Lesser restrictions remained until 19 July 21 so until then we were unable to:-

- offer provisions for groups larger than 5 in relation to pro's training and children of essential workers provisions.
- Avoid tough safety restrictions in relation to how foodbank administration, food deliveries and hardship grant administration could be facilitated.
- offer as much in the schedule due to the additional cleaning and ventilating required to make our premises as safe as possible.

This meant we were unable to accommodate everyone wishing to return straight away, or meet the need of those in crisis as quickly as was necessary at times.

Post the lifting of restrictions in summer 2021, our users fed back to us quickly how much they had missed the positive benefits of using the Circus Works. Many referred to it as their 'happy place', all said how coming to train and to play with us improved not only their mood, physical and mental state, but gave them the sense of belonging. Some commented that spending time with us was something of their own to hold dear.

The immediate negative effects on the community our provisions directly combated post restrictions included:-

Increased weight gain Breakdown of family ties Breakdown of community ties Inadequate home care support for the elderly and for the vulnerable Depression Social Anxiety Isolation Hunger Cold Unsafe space at home Lack of fun and meaningful things to do

Our Landlord Mr Richard Orsman, Director of 'Come To Good Ltd', informed us at the end of restrictions that he won't be renewing our lease in February 2024, despite giving us the assurances at the time we took up the rental agreement, that he wanted tenants for a long term let of at least 10 years! Our landlord initially did not want to adhere to our lease agreement and did try to bluster us out by February of 2022, however we have stood our ground and have some measure of protection from our lease, for as long as we can meet our full rental fees and additional bills from them.

Throughout the whole period of restrictions we have been charged, and paid full rent and bills. We did request that our landlord might consider assisting us with some measure of reduction, given that we were prevented from operating, but this fell on deaf ears. Ours was the only organisation majorly effected by the lock down restrictions on site at the industrial estate in his ownership, and the only organisation doing anything to support members of the local community in crisis. The rest of the estate including our landlord's business were back to trading fully within 3 weeks of

the initial restrictions. This estate is one of several large property assets our landlord manages via his company's property portfolio.

KEEPING A POSITIVE OUTLOOK & STAYING MOTIVATED MOVING FORWARD

We have re-emerged post Pandemic to continue to offer a timetable of use for the Circus Works Devoran, that encompasses children from 2 years up (both in and out of school), adults in the community who enjoy and value our services, professional, semi Professional and freelance performance artists and dancers, elite athletes and beginners alike.

We are able through our supporting freelancers and performers, to offer a wide range of learning and training options, the opportunities to rehearse and develop performance works, to collaborate across disciplines and forms, and to cross pollinate and innovate through that cross pollination.

CDC recognises that as well as starting to outgrow it's current resource provisions, due to the success of our project works, we are also maturing as an organisation. We have been model tenants and have not missed paying our full overheads throughout the last 15 months, despite being severely restricted operationally through out. Nevertheless in the face of the non- renewal of our lease in 2.5 years time we can only strive to continue the fight to maintain such resources and provisions in our region. We now have a strong community of users we cannot let down.

In establishing the Circus Works as a resource, it became the catalyst that brought the local circus and performance arts community together, created closer links between this community and the local community, and brought along with this all the great benefits and positive impacts of doing so. Now local youngsters can learn from the artists they know and look up to locally, learning all about alternative career choices, and benefiting from the wisdom of their experience.

We cannot see our provision of this space as a resource disappear from the region now we have established it, despite the impossible task of finding a suitable, affordable and secure space. Having survived the Pandemic, and being the little 'life boat' so many clung to for support during it, we see the immense value that togetherness brought in relation to our artistic survival, physical and mental health.

HOW WE LOOK NOW

We strongly support the development of this project, and we are committed to assisting the Jynnji project team in the development process. We would highly value the opportunity for growth to meet our expanding need, and the opportunity to be a part of a thriving, supportive, body of social enterprise, community and cultural creatives. Should we have to endure similar circumstances to the last 15 months in the future. we would not feel so isolated in such a mutually supportive environment.



CDC sees this combined application as an opportunity to collaborate to establish a creative performance arts hub, which can ensure long term security and high calibre resources to the organisations involved, and the communities that they benefit, empower and support.

When artists have no place of work and / or are not paid for their work, it essentially creates a vacuum where talent and creativity are undervalued and crumble to dust, often with artists and creatives having to take up other jobs to support their careers.





Artistic works speak volumes to all members of society and effect us in ways that deepen our insight into the world, culture, community and the self. This is why we support the Engine House of Culture (The Jynnji Project).

Access to the circus is another challenge to our community. Cost and geography play a part, but the current Circus Works space is situated within a busy yard that has very limited parking and less public transport access and as such, we are only able to really make use of the offer from them during summer months when they have a suitable outside venue that we can attend.

A purpose-built space would give us the opportunity to fully develop this working relationship and ensure greater access for all to this wonderful and inclusive art form. If this bid is successful, we would look to book space and use the facilities there to expand and enhance our offer and continue to enjoy the fruits of our relationships with all of the involved organisations.

Outside of the families provision, there would be huge scope to make use of the facility for all of our members, from the café that provided many of our cooked meals during the first 12 months of the pandemic to the space and open door it will provide as well as an aspirational and accessible learning environment currently lacking here in the South West

I've been a freelance performer and circus coach living and working in and from Cornwall for the last 14 years. During which time the one continual threat to the existence of my livelihood has been finding, and holding on to suitable spaces from which to conduct my classes, and from which to rehearse and train in relation to the artistic, and performance aspects of my work.

I am writing to you on behalf of myself and other freelance professional colleagues based in the area such as Lisa Truscott, Tyrone Herlihy and Maisie Bradley, as this has been our shared experience, particularly of late.

Places such as the Circus Works Devoran are vital to our being able to earn a living, develop our skill sets and share our knowledge with the next generation of would be professionals. Our classes also support better health and wellness for the local community, and help foster strong bonds of trust between youngsters, between youngsters and their parents or carers. Also between people from all walks of life, and different socio-economic backgrounds, who share a love of all things Circus.

The last year and a half was extremely tough for us, as it became illegal overnight for us to trade, or even to R & D future works initially. Without the Circus Works we would have been isolated and unsupported, literally starving and cold in some cases. Without such a supportive base as the Circus Works for us post Covid to work from, we have no idea how we can proceed as self employed individuals and artists.

As a freelance artist it has become the norm to have to fight to pursue any artistic endeavour, having had to move on average every 2 years over 14 years of coaching in this region. Moving on to ever increasing rental fees, and ever decreasing security, having to re-establish my client base every time. My freelance artistic colleagues and I just wish the fight could be a fair one, and that the principles of hard work and dedication to excellence in relation developing specialist skill sets, and high quality being worthwhile and rewarded were true in this context.



Airfish Circus is an informal not for profit collective of local circus professionals, semi professionals & enthusiastic members of the local community, both young & old, that enjoy putting the skills they learn at the Circus Works on show, within a safe & supportive environment. Airfish Circus is a 25-35 member family at present, from which we can forward the appropriate people to help, or to work depending on the context of the production, or event.

We create all of our own productions using the money we generate from our own performances & fundraisers. We also support local circus charity Cirque Du Ciel in their project works on site at the Circus Works & off site around the region. We usually put on at least two theatre shows of our own annually, at the Acorn Theatre Penzance. We also support both Cirque Du Ciel (CDC) & The Circus Works, in facilitating their back of house & on stage resources, for both the out of school youngsters end of year show (for CDC), & the Circus Works annual Student Gala again at the Acorn.

We began in 2016 & have brought free access big top shows, outdoor shows & workshops regularly to local events & places such as:

Exeter Arts Centre (The Phoenix) Barnfield Theatre Exeter The Custard Factory Birmingham Boomtown Fair

Although we are a small, informal association of artists, what we have done within the locality to preserve, promote & support easy access to the Physical Performing Arts for all is significant. We are not alone in being the only micro organisation, heavily embedded within the local community performing similarly significant work.

Often this work goes unrecognised because it happens without external funding, or it happens voluntarily. During the month's of recent restrictions & hardship for many, & because our members have strong ties to the local community, many amongst us were happy to volunteer & support CDC's efforts to distribute foodstuffs from their foodbank, & shop for vulnerable folk, happy to do doorstep visits to the elderly & the isolated. We witnessed small organisations such as ours, such as CDC, along with individual members of the local community supporting those around them as tier 2 & tier 3 services dwindled.

We say all this not to 'blow our own trumpet', rather to highlight what has been going on, & to help you understand our frustrations in the face of losing our 'home', our training rehearsal, research & development spaces, the venues where we can teach, perform & pass on our knowledge dwindle just as rapidly. Pressure on available space here in Cornwall in the current climate, whether for commercial, residential, public or private sector use is already extreme.

Without the Jynnji Project we have no recourse but to try & compete for non-existent spaces, with leasing fees we cannot afford, & no guarantee of not being pushed out again in the face of such profitable demand.

We need to see real support, & real action to defend the needs of micro organisations in all sectors, public, private & voluntary from local government, before the real unmeasured, unseen losses that go along with our termination have a knock on effect on local taxpayers.

ScrapStore is a generic term relating to resource centres that provide reusable materials to their local communities and exist in many parts of Britain. Materials are normally collected from local industry and comprise of clean, dry and non-toxic waste items. Many of these items are new, raw materials that are surplus to the manufacturer's requirements and would normally be disposed of. ScrapStores collect these materials and display them in their premises for users to take. Users generally comprise of local community organisations, such as: schools, playgroups, uniform youth organisations (i.e. scouts), theatre or pantomime companies, 'out of school' organisations, and so on. Items are then usually used in art, craft and creative play activities. Many ScrapStores provide a membership scheme whereby users pay an annual subscription for access to the ScrapStore and its materials. Materials are either charged for or provided free under the membership scheme. Most ScrapStores in the UK are either charities or not for profit social enterprises, although some are run directly by local authorities. Other authorities in the South West run their own Scrapstore as a part of their services to the public; these are Plymouth City Council, South Somerset District and Exeter City Council, Cornwall ScrapStore started life in 1994 as a Company Limited by Guarantee (Company No: 2981605) in an old Co-Operative building at St. Columb Road. With an initial membership of just 60 groups Cornwall ScrapStore's reputation has grown steadily over the past 27 years and now runs two stores across the county and has an average annual membership of 500 groups, families and individuals. (Before Covid) In 1998 Cornwall ScrapStore opened the first of its satellite stores in Camborne. This was followed in 2000 by a satellite store in Liskeard. We now operate two stores one at Goonamarris near St Austell and the other is located on the Cornwall College Campus in Pool. Location and opening times are available on our website <u>www.cornwallscrapstore.co.uk</u> In 1999 Cornwall ScrapStore became a Registered Charity (Charity No: 1079557) and formed a Board of Trustees made up of interested and experienced local people. Since 1997 Cornwall ScrapStore has received sporadic grant funding and support from a variety of sources to help both develop services and sustain its existence. Presently Cornwall Scrapstore relies almost entirely upon income through membership with the occasional small Grant's. Benefits The benefits of such a resource to those working creatively with children are significant. Firstly, there is free access to basic and much needed materials, such as paper, card and fabric. Secondly, there is the opportunity to sample a wide variety of unusual and exciting items that might otherwise be cost prohibitive or unavailable in the normal way. The benefits to local businesses are also significant. The availability of a project that takes unwanted materials, labelled 'waste' by most manufacturers, and offers them to the local community is in itself rewarding for socially conscious businesses. However, materials are removed with no charge to companies, therefore offering very real monetary savings. The benefits to the environment are also a significant consideration as ScrapStores save valuable resources being dumped in landfill sites or sent for incineration. Added to this are the very real savings that ScrapStores provide in the sense that members need not purchase new materials when they are taking advantage of reusable items. Public awareness of the opportunity to reduce, reuse and recycle is reinforced each time someone visits his or her local ScrapStore. Ideas for reusing resources are presented through exemplars and photographs. Often members will visit the ScrapStore to be 'inspired' by the materials, taking their cue for projects from what is on offer rather than developing a project and then purchasing the items that are needed. Each time a teacher returns to the classroom with materials from the ScrapStore he or she is representing an example of positive environmental sustainability to their pupils, and children duly respond with ideas for reusing items found in their homes for school projects. To summarise the words of Jonathon Porret: "The fact that ScrapStores exist is in itself a wonderful example of how the 3Rs philosophy works in real terms".

Cornwall is an interesting place to be a large scale mechanical artist! There is a heritage of industrial inspiration everywhere, a relic of the mining industries of a past era. This sits in stark contrast to the inspiring natural beauty of the sea and the inland areas.

The challenges for artist such as us however is twofold, namely finding a suitable space to create and rehearse future works and shows as well as connecting with a community of likeminded individuals, working across a variety of creative mediums.

Established in 2006 on the edge of London we soon found ourselves at the forefront of an emergence of large scale mechanical street theatre and art - something that the Arts Council and the country as a whole were playing catch up on, when compared to what was happening on the continent.

Working with and supported by a huge variety of partners from French giants <u>La Machine</u> and <u>Generik</u> <u>Vapeur</u> through to British organisations such as <u>Walk the Plank</u> and <u>Arcadia Spectacular</u> we were soon approached to undertake more commissions than we could feasibly manage by a variety of councils, local authorities, music and arts festivals woring on projects for the 2012 Olympics, Glastonbury Festival, the Uks top street theatre festivals and more.

In 2010 we were awarded An Arts Council Escalator Arts award to promote excellence in outdoor arts and as a result we created El Grando, probably the most ambitious mechanical installation seen in the UK to date, collaborating with fellow artist <u>Paka the Uncredible</u>.

Relocating to the South West in 2012 we took a sabbatical period in 2016 to focus on smaller personal projects and family and are now undertaking new commissions and large scale projects once again to rival the most exciting anywhere in the UK.

Finding a suitable, affordable space to work and create things on such a scale has always been an issue for all artists in this area. It is for that reason that we wholeheartedly support this application and if it receives the support that it deserves we know that it will be a base for both established artists to work and collaborate on exciting new projects, as well as supporting new and emerging artists and performers in the emergence of their own art. At this far end of the country such support and the potential creation of new opportunities for developing new artists is invaluable.
